Hip Guarantee

This puppy is guaranteed against severe hip dysplasia up to one year of life. To validate your
guarantee for hips, the following steps and conditions must be met:

1. All expenses, including radiographs, are solely the buyer's expense.
2. The dog must be properly positioned as described by Dr. Davis, DVM, "The Importance of Precise Positioning Technique" for OFA radiographs for Canine Hip Dysplasia in this Youtube link. NO OTHER techniques or positioning will be accepted.

3. Females must be x-rayed 6-8 weeks away from any heat cycle.
4. Diet is extremely important for puppy's health. Grunberg puppies are to stay on an approved, complete, whole foods, raw diet. This guarantee is null and void if the puppy is not kept exclusively on the recommended diet.

Steps to take if your dog is suspected of having severe hip dysplasia:

1. Grunberg must be contacted within 24 hours of radiograph results.
2. Grunberg reserves the right to view all radiographs and have her choice of veterinarians also view the radiographs.
3. If there is a disagreement concerning hip quality between buyer and seller, then the x-rays must be sent to the OFA where a neutral body will judge.
4. If severe hip dysplasia is confirmed. AKC papers must be permanently surrendered to Grunberg and the dog must be spayed or neutered within two weeks of diagnosis.
5. The buyer is then entitled to a replacement puppy to be selected by Grunberg as soon as one is available.

We also guarantee our puppies against weak nerves or poor temperament. Claims must be made before one year of age. All evaluations are at the sole discretion of Grunberg. The buyer is entitled to a replacement puppy if Grunberg agrees there is a temperament flaw.

Please note that all disputes must be settled in Henderson County, the home of Grunberg.

The buyer also understands that in the event s/he is unable to provide a home for this pup at any time in the future, Grunberg must be notified and offered first right of refusal.
